

Haynes Township Board Meeting Minutes
Haynes Township Hall
March 4, 2026, 7:00 p.m.

Supervisor Effrick called the meeting to order at 7:00 p.m. Board members present: Supervisor Effrick, Trustee Campbell, Treasurer Campbell, Trustee Quick, and Clerk Quick. Guest: Craig Johnston, County Commissioner.

Supervisor Effrick made a motion to approve the February 2, 2026 meeting minutes seconded by Trustee Quick, all yeses, motion carried.

Treasurer Campbell read the Treasurer's Report, and stated there is \$475,538.87 in the General Fund. Supervisor Effrick made a motion to accept the Treasurer's Report, seconded by Trustee Campbell, all yeses, motion carried.

Clerk Quick read the bills totaling \$7,206.18. Trustee Quick made a motion to pay the bills, seconded by Supervisor Effrick, all yeses, motion carried.

Clerk Quick read the Assessor's Report.

Supervisor Effrick made a motion to approve the Huron Community Bank and the Alpena Alcona Area Credit Union as the financial institutions, seconded by Trustee Campbell; all yeses, motion carried.

Supervisor Effrick made a motion to approve the Haynes Township Board Meeting Dates for fiscal year 2026-27, seconded by Treasurer Campbell, all yeses, motion carried.

Supervisor Effrick made a motion to accept all contracts: C & S Dust Control and the fire contracts with Harrisville (\$9500) and Lincoln (\$9000), seconded by Treasurer Campbell, all yeses, motion carried.
